Good Day Nansemond River Power Squadron Members!

With spring rains coming our way it's time to consider what we can do to reduce the water runoff into the Chesapeake Bay and the rivers that flow into it. Every raindrop that falls from the sky finds its way to the watershed. Along the way that one drop is joined with all the others that fell and gather every little bit of pollution you could imagine. Chemicals we put on our yards, pollution from our travels on the roadways. Just about anything and everything you

can imagine finds its way to our waterways. All I ask is that you consider the impact you have on this neverending process and take a moment to consider what you can do to reduce your addition to the problem.

Linda and I don't use weed killers and only use natural nutrients on our lawn. The first flowers are our bees first nectar of the year. Just think what would happen if we didn't have bees! We use cloth bags at the grocery store to reduce the plastic bags coming our way. We mulch when we mow. When we attended the Oyster Roast the Ruritans collected the shells. Additionally, the Virginia Department of Wildlife Resources now has a program to collect information on reported abandoned and derelict boats and have them removed and properly disposed in an effort to clean

We will be giving a little more thought about where and how far we might cruise with the current fuel prices. Our thoughts are that we love boating, we love going places, and we own the boat to use it. I am still holding hope the fuel price will change soon. However, we should not let that stop us from getting our boats ready and in good shape. One of the many questions I get asked while I am doing the vessel inspections is "what can we do with expired flares." I have heard everything from giving them to the fire department, and breaking them in half to soak in water for a day or two then dispose of them. Recently I heard two other remedies that I cannot confirm, but I thought I would pass them on. One was the city hazard waste disposal sites will take them, and the other was VDOT will take them and use as hazard flares on the street for traffic control

On to what we can do for boat maintenance. Time to check the following to get ready:

Filters * Fuel lines * Thru hulls * Safety Equipment Dock Lines * Running lights

And I am sure there are many other items pertaining to your specific boat that can be checked. Another little trick I heard was to put your dock lines in a pillowcase and put them in your washing machine with fabric softener. This will make them soft and more flexible. This is one I will try and pass on the results; my lines need it. Hopefully by the next newsletter, we can talk about some cruising on the water.

There is a Boat Operator Certification Program available which is a hands on program that can be done on your boat. It starts with an Inland Navigator check out and goes up through Coastal Navigator, Advanced Coastal Navigation, and Offshore Navigator. We can do the check out on your boat or a friend's boat if you don't have one at the moment.

The ABC national web site offers access to several videos. One of them features an unsuccessful attempt a couple of summers ago to drown Norman Fisher. There are many subjects available and it would be a good way to spend a rainy afternoon.

This is also a good time to review anchoring procedures and actually test your anchor gear. Many people operate their boats as marina hoppers and rarely use their anchor gear. If you need your anchor when something goes wrong with your engine, you don't want to find out something isn't working then. Things tend to work better when they are actually used so use that key system occasionally.



SHARKS IN THE WATERS

I am using this catchy phrase to highlight what is happening in the area of boat documentation. Some of us have our boats documented with





As a 3rd party they have direct access to your documentation number and data associated with it, which somewhat confirms that you have USCG on the phone. Such is not the case and after a few guestions you arrive at one that tweaks your interest when they want the SSN of the owner and co-owner. I should have known right then that I was not talking to USCG (but in the heat of battle, my certification had expired over a month previously while I was in the hospital), but confused I continued. They are quick to respond and will take advantage of the situation allowing you to think you have USCG on the phone should you be calling rather than surfing the net for USCG which I should have done. Then comes the comments that all payments are non-refundable (thatshould have been another tweet but still thinking

I am talking to USCG I continued) and confirmed a charge of \$750 for recertification and 5 years renewal.

That in itself should have been an electric charge to my system as to exactly whom I was speaking with. But I continued and immediately confirmed with my co-owner that in 2018 she had received a letter from them and she had signed on for 3 years of renewal all the while I am paying my yearly renewal with USCG receiving my renewal notice at least a month ahead of my expiration date. Covid could have disrupted the snail mail, along with receiving mail only once or twice a week. Thus my expiration date passed, and now I needed to be legal. An immediate recall to MDC as to my request for cancellation where upon the same individual said all I needed to do was send an email that "I thought I was talking with USCG" and it would be canceled. True but that non-refundable issue did not rear its head until several emails later when I asked for clarification of my cancelation and a refund to my credit card. I then called USCG in Falling Waters West Va. I was informed that they had no affiliation with MDC and spend hours talking with members such as myself about the excessive expense they charge and to be honest leave you hanging with items like it take 8-12 weeks to get your results. While on the phone, I gave my email to USCG and paid my \$81 for recertification. I got it in the mail within a week. I immediately called my Credit Card Company and complained about the charge, ultimately they helped me get a rebate, but even that took time. Lesson? Don't be duped by MDS.!

It's Time to "SPRING" For Boat Safety!





Spring has arrived, and P/C Frank Brown, AP-IN and his merry band of vessel inspectors are stirring from their winter hibernation and going in search of boats with expired stickers.

Checking your safety equipment is always a good practice and having another set of eyes looking at your gear increases the thoroughness of the inspection. There are some new fire extinguisher rules in effect now, and you want to make sure you are in compliance. It never hurts to put your hands on the equipment so is refreshed on the leasting of your kit.

Flares have an expiration date for a reason. When they over age, the failure rate goes up considerably. Some expiration dates are sales tools, in this case that is not true. Also remember that if you have a electric flare, you still need a day time signal like an orange flag or smoke flares. Smoke is not effective in winds over 20 knots because it dissipates too quickly, so having the orange flag is still a good idea.

Give your hose clamps a twist and make sure they are solid and tight, and exercise your seacocks while you are at it!



It is time to get back on the water. Be safe out there.


