


The current Maryland boating rules are below (as of 13 May 2020):

- ★ Boaters must be with immediate family members or people with which they reside. No more than 10 people can be on a boat at one time, including captain and crew.
- ★ Boats must be distanced from each other by at least 10 feet and are prohibited from rafting up, beaching, or having rendezvous events.
- * Boats are prohibited from docking at restaurants or bars.
- * Vessel and boat races remain prohibited.
- * Marinas can reopen to recreational boaters, but must adhere to the Maryland Departments of Commerce and Health guidelines.
- ★ Pump-out stations and boats may resume operations under the Departments of Commerce and Health guidelines.
- ★ All normal boating rules and regulations are in effect and must be followed.

What Really Matters at Sea P/C Rich Hughes, SN-IN


As chairman of the squadron's Safety Committee, I thought it was important that I submit at least the first article for the Anchor Watch. I did that last month as I was "Staying at Home" to protect myself from COVID19. For the second article, I did what every good researcher would do, search the internet. I used the search criteria, "Safe Boating." There is no shortage of articles on the web. I read articles until my eyes began to cross. The articles talked about safety equipment, safety practices, safety courses, safety . . . I finally found an article that struck a nerve with me. The article humorously summarized all the articles that I had read. It appeared in the November 9, 2017 issue of

Sounding Magazine. The article was titled "My Five Rules: What Really Matters at Sea," and was written by Mario Vittone, a retired Coastguardsman.

In the introduction to the article he concludes that "Every rule ever written into federal or international regulation for the safe operation of vessels at sea pertains to one of five basic rules." The five rules are:

Rule 1: Keep the water on the outside of the boat.

This rule addresses aspects of hull materials, sea valves and spare hose clamps. A hole in a boat is not a good thing. But, he claims that water creeps into vessels most often through holes drilled into the hull intentionally. So, if you put a hole in your boat, ensure that you have protection so it does not let water in unintentionally from a broken-through hull or failed seacock. Double clamps are necessary for all hoses that connect to the hull below the waterline.



Rule 2: Keep all the bad stuff that's inside the boat inside the boat.

Bad stuff can spill into the boat. Keep it from being leaked or shipped overboard. These bad things can include fuel or holding tank leakage. Neither of these items is a good thing to have in the bilge, but it is even more problematic if they are leaked or discharged overboard.

Rule 3: Keep the boat from catching fire or blowing up.

A fire on-board does not lead to a good day on the water. Two critical shipboard systems to monitor closely are the electrical and the ventilation systems. Your life depends on these systems being correctly installed and maintained meticulously.

Rule 4: Keep everyone who's on the boat on the boat and healthy.

Most recreational boats have lifelines and some semblance of a first aid kit. Check your first aid kit annually to ensure that items are not out of date or used up. Inspect your twisted cable lifelines for internal corrosion. Is your first aid kit adequate for anticipated emergencies? Should you consider a first aid training course to sharpen your first aid skills?



Rule 5: If any of the above changes, call someone.

If you are confronted with an emergency or potential emergency, notify someone for help sooner rather than later. Failure to timely call for help will never improve the situation.

Piloting Through Covid19 P/C Rich Hughes, SN-IN

The Winter 2020 Marine Navigation Class, AKA Piloting Class, started off normally at Annapolis High School. Thanks to our great PR department, we had the largest class in recent memory with 17 students. And then came COVID19 and the class went into hibernation. We lost two weeks of instruction until Michael Maszczenski proposed that we try to teach using ZOOM. Prior to his suggestion, I thought that zoom is what jet aircraft did.

We polled the students to see if they were interested in continuing the class via distance learning, or delaying the class until we could reconvene in a

classroom. At the time, we didn't have a full appreciation for the severity of the pandemic. The good news was that the class was adventuresome and wanted to proceed.

With a little modification to my home office, (I had to borrow a camera and purchase a headset,) and a great deal of help from Mike, we were up and running. Using ZOOM required a bit of a learning curve for everyone, but the students were patient and supportive. For the most part, communication issues using ZOOM were minimal. Several of the students had some experience with Zoom and helped the less experienced wrestle with the idiosyncrasies of the new tool.

As an instructor, I enjoyed the opportunity to work with a new tool but missed to face-to-face contact of the classroom. A very large part of the Piloting class is teaching use of the USPS plotting tool. In a classroom, I can sense the comfort level of each student as I progress and can provide hands-on instruction until each student is comfortable with the plotting tool. This is not practical in a distance learning environment.

As I write this article, we have completed the instruction, and the students are working on the take-home exam. It will be very interesting to compare the average test results of this class that experienced the course via distance learning versus those students that learned in a traditional face-to-face environment.

Lorrie and Jeff Short represented ASPS for a 50th Earth Day clean up of Severn Run, the headwaters of the Severn River.






John Wilmot and Betty Rouse Wilmot are holed up in Garrett County and skiing on Deep Creek Lake.










It was a great spinnaker run on the Chesapeake. They got home on the evening of 15 May. That made it a remarkable 8 days for a 720 mile trip.

Lt/C Michael Maszczenski, Jr., N


